प्री-मैट्रिक छात्रवृत्ति योजना 2008-09 हेतु आवेदन

अल्पसंख्यक छात्र / छात्राओं के लिए खुशखबरी

राज्य के सरकारी / गैर सरकारी मान्यता प्राप्त विद्यालयों में पढ़ने वाले अल्पसंख्यक (मुस्लिम, ईसाई, सिख एवं बौद्ध) समुदाय के कक्षा 1 से 10 तक के विद्यार्थियों के लिए यह योजना है। विहित प्रपत्र में आवेदन पत्र दिनांक 31.07.2008 तक मुख्य कार्यपालक पदाधिकारी शिया वक्फ बोर्ड, 34 अली ईमाम पथ (हार्डिंग रोड) पटना - 1 के पते पर संबंधित शिक्षण संस्थान के माध्यम से डाक द्वारा भेजा जा सकता है। लिफाफे के उपर मोटे अक्षरों में "प्री-मैट्रिक छात्रवृत्ति" लिखा होना चाहिए।

अर्हताएं

1. गत परीक्षा में 50 प्रतिशत से कम प्राप्तांक न हो (वर्ग 1 को छोड़कर)।
2. विद्यार्थी द्वारा कोई दूसरी छात्रवृत्ति नहीं ली गयी हो।
3. अभिभावक के कुल श्रोतो से वार्षिक आय 1 लाख रुपये से अधिक न हो।
4. 30 प्रतिशत छात्रवृत्ति बालिकाओं के लिए सुरक्षित है।
5. एक परिवार के दो सदस्यों से अधिक यह छात्रवृत्ति नहीं दी जायेगी।
6. निर्वहन भत्ता विद्यार्थी के खाते में हस्तांतरित किया जायेगा।

छात्रवृत्ति की दर

1. छात्रवृत्ति एक वर्ष के लिए स्वीकृत की जाएगी।
2. कक्षा 1 से 5 तक के विद्यार्थी को 1,000/- रुपये वार्षिक देय होगा।
3. कक्षा 6 से 10 तक के विद्यार्थी को नामांकन शुल्क अधिकतम 500/- रुपये या वास्तविक तथा शिक्षण शुल्क अधिकतम 3,50/- रुपये नासिक या वास्तविक एवं निर्वहन भत्ता होस्टलरों के लिए अधिकतम 6,000/- रुपये वार्षिक या वास्तविक तथा डे-स्कॉलर के लिए 1,000/- रुपये वार्षिक देय होगा।
